The Buyer agrees that the Brokerage is entitled to be paid a commission of two percent (2%) of the sale price of the Property plus GST from the seller of the property or the Listing Brokerage. Should the Brokerage be unable to obtain an agreement in writing from the seller or the Listing Brokerage to pay the full commission described above, the Buyer will be so informed in writing prior to submitting an offer to purchase. 4. **REPRESENTATION:** I acknowledge that the Brokerage has provided me with written information explaining representation relationships, including information on Seller Representation, Sub-Representation, Buyer Representation, Multiple Representation and Customer Service. The Brokerage shall assist the Buyer in evaluating the Property and shall represent the Buyer in an endeavour to procure the acceptance of an agreement to purchase the Property. The Buyer hereby agrees that the terms of any Buyer's offer or agreement to purchase the Property will not be disclosed to any other buyer. The Buyer hereby appoints the Brokerage as representative for the purpose of giving and receiving notices pursuant to any offer or agreement to purchase the Property negotiated by the Brokerage.

- **5. ENVIRONMENTAL INDEMNIFICATION:** The Buyer agrees to indemnify and save harmless the Brokerage, the vendor and the Listing Brokerage from any liability, claim, loss, cost, damage or injury as a result of the Property being affected by any contaminants or environmental problems.
